90-DAY LIMITED WARRANTY

If your unit is found to be factory defective during the first 90 days, it will be repaired or replaced for the handling and inspection fee only. If the unit is found to have been consumer damaged or abused and therefore not covered by the warranty, then you will be advised, in advance, of repair costs.
